

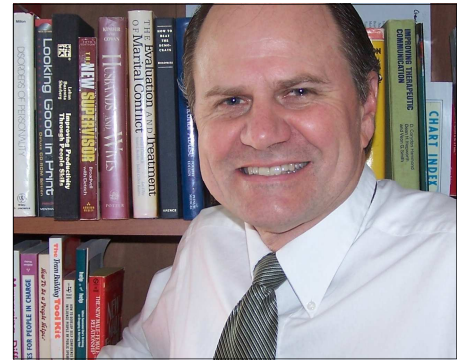

SUBSCRIPTION LICENSE AND AGREEMENT

Thank you for using FrontLine Employee!

FrontLine Employee is the most innovative workplace newsletter program ever. Started in 2001, you now have an editable, professional, unique, easy, and inexpensive newsletter program for your work organization. FrontLine Employee content may be edited or used as your own content in an existing publication or template. Content is only for your employees or the employees of your customers.

1. You will receive an electronic copy of the newsletter before the first of the month of issue, usually no later than the 26th of the preceding month. Phone us if you do not receive your emailed copy by the 26th.
2. This license gives you permission to edit, reproduce, and distribute FrontLine Employee content to employees of, or served directly by your organization.
3. You may place content of the newsletter on an internal website without restriction. However, if you post FrontLine Employee to a website accessible via the Internet, you must use a password or some other page protection to prevent use by unauthorized persons. (Contact us if this is a problem for you so we can discuss keeping the content safe.)
4. Frontline Employee does not permit the combining or transfer of paid subscriptions or subscriptions eligible for renewal. A "transfer" is defined as an existing paid customer who cancels or allows their subscription to expire so it can be serviced or "picked up" by another paid subscriber to avoid the renewal payment, such as an EAP provider. This creates net subscription losses to DFA Publishing and Consulting, LLC violates of our terms of service and jeopardizes our ability to continue publishing for the benefit of all.
